As of January 2022, 151 academics from 16 different countries applied for membership. #### **Association-Brief History**

A Brief Story Of The Transition Process From The Platform/Initiative Period To The Association The conversion process to the Association

In the anti-democratic process that took place in Turkey between 2014 and 2016, great pressures were created on intellectuals and scientists. After the unfortunate attempt of July 15, thousands of scientists were expelled from universities and hundreds more were arrested. In this process, those who had the opportunity to go abroad had to immigrate to various countries of the world.

Who knows what new opportunities this reluctant, painful and risky migration would open up for the scientific world and scientists!

Indeed, that happened.

A group of scientists who had been acquainted before took the initiative and attempted to open the doors of rejoining the world of science.

This initiative has revealed a new platform that will be a roof for scientists in Germany.

The first attempt took place in the new and humble environment of scientists who had landed at the "0" point in October 2018. It was held in a temporary guesthouse called "Heim" in Germany by 3 academics and 1 administrative staff who had the opportunity to go abroad in an unfortunate and difficult process.

In this brainstorming, scientists concentrate on the following priorities and discuss possible solutions;

To be able to adapt more quickly to the social and cultural conditions of the country they are in. To be able to produce motivation and research ground to return to research.

Making efforts to explain the antidemocratic process in Turkey, the injustices, persecutions and imprisoned scientists to the European public and the scientific world.

Of course, these were goals for more than a few people and involved a lot of work. Therefore, they try to reach more and different scientists. They decide that the best way to do this is to gather willing people together under the umbrella of a non-governmental organization (Initiative).

As a result of intense efforts, an initiative called Academics at Risk was established on 20.04.2019 with the scientists they could reach and persuade in various European countries, especially in Germany.

Working groups were formed with a series of meetings held in the period after the establishment, task distribution was made and activity plans were put into writing to achieve the determined objectives.



In this process, which lasts about 3 years, a large number of activities are carried out while the plans are realized.

A few examples of what has been done;

First of all, the web page and social media organization has been completed.

Survey studies were carried out to get opinions and views on the platform and to determine the expectations and needs of scientists.

After the needs were determined, a series of seminars and activities were held on the following topics;

- The Philipp Schwartz Initiative Scholarship Application, Roadmap and Information Seminar,
- Roadmap Seminar for Young Scientists who have to leave their doctorate or master's degree, or who want to pursue a doctorate, master's,
- Preparation for the German Academic World and Initial Projects and Scholarships Seminar,
- Preparation of application files, Seminars on Finding a Job in Germany,
- Seminar on making Ausbildung, Weiterbildung, Fortbildung, Umschlung in Germany,
- "Memorial and Story Writing Event" was organized
- "Academic Freedom in Turkey Report" was prepared after July 15.
- A report was prepared for the "Universal Periodic Review (UPR)" regarding the member states of the United Nations and two scientists representing the Initiative made a presentation in Geneva. These activities were instrumental in meeting new people. There has been a continuous increase in the number of members with new scientists. The accumulated knowledge and experience and the increase in the number of new members encouraged the Initiative management to take a step forward. To achieve some further goals, it was decided to switch from the initiative legal entity to the association legal entity.

With the excitement of a new establishment, a new by-law study was initiated. Although there was no opportunity to meet physically, discussions were held with the members and potential members in six different states on the mission, duties and core values of the Association, via video conference method.

With the experiences gained in three years and the feedback received from the meetings with the members, the charter and basic values of the Association were formed.

The Platform or Initiative was now ready to be transported to a different dimension!

The charter of the association was finalized at the Online General Assembly meeting held on 17.04.2021, the Board of Directors and the Audit Committee were elected and the Academics at Risk e.V. Association was established.



#### **Mission**

#### WHO ARE WE?

Academics at Risk was an initiative that was a group of scientists who are trying to reintegrate the scientists at risk who had to leave their countries and scientific institutions to the scientific world. Now it has grown and turned into an association with the support of many academicians.

This initiative is formed within humanitarian responsibility as well as professional solidarity.

#### MISSION OF THE ASSOCIATION

The association aims to promote and guide scientists at risk, deprived of their primary rights and freedoms, herewith they could continue their scientific studies in a free and safe environment.

As a multicultural and global organization, the main goal of the association is to carry out joint projects with international academic and humanitarian organizations to reintegrate scientists at risk into the science world






#### Statute and Basic Principles Studies were carried out in the **Reorganisation Process**

Academics at Risk initiative was founded in 2019 with the initiative of Turkish scientists who were exposed to immigration. The two-year activities of the initiative and necessity to produce permanent solutions for its members raised the need to become an

association. In order to carry out more comprehensive activities and to produce permanent solutions, the initiative has been transformed

into an association.

The initiative administration adapted a participatory method for a smooth transition by establishing exchange of opinions programs. In this transformation plan, "negotiation programs" were prepared to exchange ideas with stakeholders. Duties, basic functions and working principles were determined by discussion in these participatory programs.



A team made up of members of the initiation discussed the statute of the association in February 2020.

After the preliminary series of meetings, the statute writing team held a series of negotiation meetings with current and potential members from six regions in Germany.

A draft statute was written in June 2020 with the contributions of Academics, NGOs and Law experts.

The statute was finalized in December 2020. It was sent to the Finance Office for Review and Opinion. The official approval process was started by holding the General Assembly on 17.04.2021 (Notary and Court process) In.. 2021, it was approved as a "Public Benefit Association".



#### The statute has been prepared to perform the following basic duties;

- Creates a network of relations among scientists,
- Provides support and guidance for scientific studies,
- Encourages academic development and provides career support,
- Contributes to the development of universal, social, cultural, and educational issues,
- Establishes and develops relations with national and international institutions/individuals.
- Encourages and supports project studies,
- Encourages and promotes the establishment of research institutions

#### The writing and Announcement of basic principles:

Along with the statute writing process, the process for determining the basic working principles was also started.

The previously established "Guiding Principles for the Statute" was revised in the light of information gathered from local meetings and composed into a draft called "The Basic Principles" by the new Board of Directors.

This draft then was announced as "The Basic Principles" in June 2021 with the help of feedback from the Cloud Discussions in Google Docs.

Further work had to be done to applicable "The Basic Principles", which consisted of abstract statements. For this purpose, "Institutional Values" and "Codes of Behaviour" were produced in order to bring the principles to life and guide practices.

Finally, The Board of Directors has announced "The Basic Principles" on the association's website, with a commitment to their implementation as basic working principles.



#### **Basic Principles**

The Board of the Association has determined and committed to the following working principles:

#### 1. LEAN ORGANIZATION

- 1.1. A simple structure and minimum hierarchy: minimum units and personnel, employment through projects, and service procurement.
- 1.2. Making use of cloud organization, virtual communication, and virtual training methods.
- 1.3. Efficient use of resources; minimum stationery, minimum space, giving priority to plain and functional in all aspects.

#### 2. PARTICIPANT DECISION MAKING AND INFORMATION SHARING

- 2.1. Pluralism, democratic inclusion in governance
- 2.2. Active and participatory member policy.
- 2.3. Delegation, inclusion, and sharing:
- 2.3.1.Respect for the vote and ensuring of the meeting democracy providing an open agenda, free discussion environment, and making decisions under democratic methods.
- 2.3.2. Taking into account and respecting the other person's opinion.
- 2.3.3. Free expression of thought.
- 2.3.4. Making a positive and concrete contribution.
- 2.3.5. Respect for the decision and the decision council.

#### 2.4. Emphasis on solidarity and utilizing from Expert Opinion

- 2.4.1. Basing the subject that requires professional knowledge on professional opinion
- 2.4.2. Establishing a continuous and professional relationship
- 2.4.3. Establishing and effectively managing a feedback-based suggestion system.
- 2.4.4. Consulting and informing the members of the General Assembly periodically



### **Member Profile**



#### **Akademische Reise mit Neutrinos**




**Event 1:** Seminar (Public Activity-Webinar)

### **Working Group of Interdisciplinary**

The interdisciplinary working group gathers on behalf of the Academics at Risk e.V. Association and carries out its studies. The purpose of the interdisciplinary working group is to assist academics who have immigrated from their own countries in their academic studies, to contribute to the solution of the problems they may encounter in this process, and to provide the necessary support so that they do not break away from academic life, in line with the founding objectives in the charter. The interdisciplinary working group consists of different disciplines.

The interdisciplinary working group consists of the following disciplines:

- Political science and international relations
- Religious sciences and theology
- Educational science
- Law sciences
- Engineering sciences
- Natural Science
- Linguistics and literature sciences
- Economics and business sciences
- Medical sciences

In this context, in order to keep the academicians in the disciplines alive academically, alternative and interdisciplinary academic seminars were conducted.

Guidance has been given to many academicians who will apply to academic programs such as Philipp Schwartz-Initiative, Volkswagen, DAAD, and SAAR. Both national project applications such as DFG and DAAF and international project applications such as HORIZON are being investigated. In this context, participation in the meetings of the institutions that support the project is carried out.

#### Events of Economics and Business Discipline Group

Event 1: Seminar (Webinar)

Event subject: EU Projects

On August 1, 2021, the seminar titled "EU Projects" was held on online as a meeting of the Economics and Business Discipline Group

Members of the Economics and Business Discipline Group attended the seminar.

The aim of the seminar is to inform the group members about EU Projects and to encourage them to work on a joint project.

The seminar lasted over an hour. The seminar was given in an interactive way and many questions were answered. EU project funds and application details were shared. In addition, it was discussed how to realize a project title for scientists exposed to migration.

After the seminar, the members of the discipline group got detailed information about EU project funds and applications. They were informed about how to proceed in joint project applications.

Event 2: Seminar (Webinar)

Event subject: Academic Publication Processes: Experiences

On October 24, 2021, two group members, who were working together, gave a seminar on "Academic Publication Processes: Experiences".

Members of the Economics and Business Discipline Group attended the seminar.

The purpose of this seminar was to inform the group members about publishing in journals included in the international citation index.

The seminar lasted about an hour. Various experiences were shared at the seminar. The article focuses on choosing the right journal, communicating with the editors, and learning from negative results.

After the event, the members of the group gained knowledge on issues such as publishing in the international citation index, overcoming the problems, if any, and determining the correct journal.



**Event 3:** Seminar (Public Activity-Webinar)

Event subject: "Datenschutz" The 10 Most Common Mistakes in Data Protection

On November 7, 2021, a seminar titled "The 10 Most Common Mistakes in Data Protection" was held onby a group member.

Members of the Economics and Business Discipline Group attended the seminar.

It was to inform group members about data protection, which is an important issue for everyone today. In addition, after identifying the mistakes made by many people, it was to get information about what to do in order not to repeat them.

The seminar lasted over an hour. It explained what the 10 common mistakes are in data protection. It was explained what should be considered in order not to repeat these mistakes.

The group members who listened to the seminar were informed about data protection, which is one of the important problems of today. In Germany, they got detailed information about Datenschutz.

**Event 4:** Seminar (Public Activity-Webinar)

Event subject: Socioeconomic Structure of Germany

The seminar was held on 21.11.2021. The scientist who presented the seminar shared his knowledge and experience on the economic structure, education system, innovation infrastructure, job market and similar issues in Germany.

Members of the Economy and Business Discipline Group attended the seminar.

It was to inform the group members about the socioeconomic structure and job market of Germany.

The seminar lasted an hour. A Scientist gave information about the characteristics of Germany's economy and the difficulties in the job market.

The group members who listened to the seminar learned about the socioeconomic structure of Germany today. In addition, group members who had to look for a job had detailed information.

#### **Events of The Natural Sciences Working Group**

Event 1: Seminar (Webinar) (öffentliche Tätigkeit)

**Event subject:** Academic Life and Academicism in Germany

The seminar was held on 29.04.2021. Academics who are members and non-members of the Academics at Risk Association and who have completed their Masters and Doctorate degrees (13 people) attended the seminar. The meeting was held via Zoom.



This seminar is aimed that people who want to continue their professional life at universities in Germany to get to know the German academic system and have information about its difficulties and opportunities.

The seminar lasted 1.5 hours. In the seminar, two academicians working at universities in Germany explained what qualifications they need to have in terms of education, language and skills in order to work at universities and higher schools in Germany. They answered the questions.

Information about the necessary qualifications and roadmap to work as an academician at universities in Germany was obtained.

- It was discussed that scholarship opportunities, such as the Phillip Schwartz Institute's scholarship, could be the first step towards integrating into academic life.
- It was emphasized that working as a researcher should be considered a priority, since the language in universities is completely German.

Event 2: Seminar (Webinar)

Event subject: YouTube channel and making his own videos

The seminar was held on 29.05.2020. Academics who are members and non-members of the Academics at Risk Association and who have completed their Masters and Doctorate degrees (11 people) attended the seminar. The meeting was held via Zoom.

This seminar was intended to provide training to people who already have knowledge and experiences, and who want to share it with people through a YouTube channel.

The seminar lasted 1 hour. The information was given about how to open a YouTube channel, how to open an account, and how to increase the number of followers and views. Information on how to edit the captured videos was given as well.

It was a productive training on how to open a YouTube Channel, how to increase the number of followers and viewers, how to shoot videos, how to increase their quality, and how to make the videos ready for broadcast.



Event 3: Seminar (Webinar)

Event subject: Experience sharing about the Volkswagen Scholarship

The seminar was held on 26.06.2021. The seminar was given by one of our members, who has been already working with this scholarship, about the conditions of the Volkswagen Scholarship and the application process.

Academics who are members and non-members of the Academics at Risk Association and who have completed their Master's and Doctorate degrees (13 people) attended the seminar. The meeting was held via Zoom.

The aim of this seminar was to inform academicians who completed their PhD and got refugee status in Germany about the Volkswagen scholarship.

The seminar lasted 1.5 hours. At the seminar, the opportunities provided by the Volkswagen scholarship, the conditions and the processes were explained. Their differences were highlighted by the Phillip Schwartz scholarship. Participants' questions were answered.

Information was obtained about the conditions and procedure for applying for the Volkswagen scholarship.

- It was understood that Volkswagen Institution had temporarily stopped granting scholarships and applications at the time of the seminar.
- If there are new scholarship announcements, our lecturer who gave the seminar stated that he can mentor and help those who are interested.

#### **Events of The Law Sciences Working Group**

Event 1: Seminar (Webinar)

**Event subject:** Restrictions on Domestic Self-Defense in the Framework of German Criminal Law

The seminar was held on 12.10.2021. The seminar was held to provide the members of the Law Working Group with the opportunity to get to know German Criminal Law closely and compare it with Turkish Law, and to provide motivation for young Academics who want to continue their academic careers in Germany.

### **Auditor's Report**

#### **Academics at Risk Association Internal Audit Reports**

The 2021 fiscal year audit process started after the appointment of an auditor from within the Audit Board. The auditing process was completed and submitted to the Board of Directors within the given four-week period of informing (07.03.2022 and 01.04.2022).

The compliance of the association's 2021 activity records, member records, expenditures and income-expenditure records to the legislation and the association's statute was audited with the help of interviews with relevant persons and a detailed examination of records.
